4. FIRST AID MEASURES

Description of first aid measures

General advice Do not get in eyes, on skin, or on clothing. Do not breathe dust/fume/gas/mist/vapors/spray.

Eye contact Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area. Call a physician immediately.

Skin contact Wash off immediately with plenty of water for at least 15 minutes. Remove contaminated clothing and shoes. If skin irritation persists, call a physician.

Inhalation Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician or poison control center immediately.

Ingestion Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Clean

mouth with water and drink afterwards plenty of water. Call a physician or poison control center immediately.

Indication of any immediate medical attention and special treatment needed

Note to physicians Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

5. FIRE-FIGHTING MEASURES
