## 4. FIRST AID MEASURES

### Description of first aid measures

<b>General advice</b>	If symptoms persist, call a physician. Do not breathe dust/fume/gas/mist/vapors/spray. Do not get in eyes, on skin, or on clothing.
<b>Eye contact</b>	Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. Call a physician.
<b>Skin contact</b>	Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Immediate medical attention is not required. If skin irritation persists, call a physician.
<b>Inhalation</b>	Remove to fresh air. If breathing is irregular or stopped, administer artificial respiration. Avoid direct contact with skin. Use barrier to give mouth-to-mouth resuscitation. Oxygen or artificial respiration if needed. If symptoms persist, call a physician.
<b>Ingestion</b>	Do NOT induce vomiting. Clean mouth with water and drink afterwards plenty of water. Never give anything by mouth to an unconscious person. Call a physician.
<b>Self-protection of the first aider</b>	Use personal protective equipment as required. Avoid contact with skin, eyes or clothing.

<b>Note to physicians</b>	Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

### Specific hazards arising from the chemical

Will release oxygen when heated, intensifying a fire. Acidic mist may be present; self contained breathing apparatus should be used. In the event of fire and/or explosion do not breathe fumes. May cause sensitization in susceptible persons. Thermal decomposition can lead to release of irritating and toxic gases and vapors.

Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Clean contaminated surface thoroughly. Pick up and transfer to properly labeled containers. Sweep up and shovel into suitable containers for disposal. After cleaning, flush away traces with water.

**Storage Conditions** Keep container tightly closed in a dry and well-ventilated place. Keep out of the reach of children. Keep containers tightly closed in a cool, well-ventilated place. Keep in properly labeled containers.

**Incompatible materials** Strong acids. Do not mix with other swimming pool/spa chemicals in their concentrated forms. Avoid contact with water on concentrated material in the container.
